

Emma Jean Rosner Information:

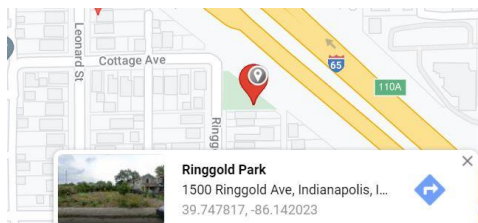
Emma Jean Rosner was born in February 1906 to Rosemary Owens and Jessie Garber. She was adopted by Louis Jasper Riley and Christina Hoop Riley, who lived in the neighborhood. According to family lore, Rosemary and Jessie were from different faiths and whereby their families would not approve of their having a child together.

Below are some pictures of the location of where the Rileys lived at 1505 Ringgold Ave, Indianapolis. The home is no longer standing due to the creation of U.S. Interstate system in the 1960s and 70s. I-65 was built just behind where the house was, so it had to be torn down.

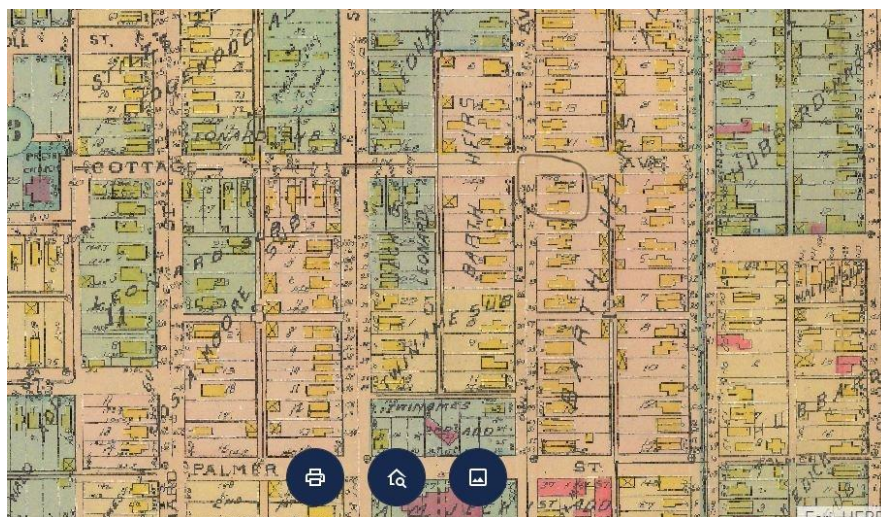
The land where this house was located is now a playground/park.

I was unable to find a record for either Jessie or Rosemary in the census to show proximity to where the Rileys lived. Jessie and Rose M show up in the 1930 census, which shows Rose M was born in Indiana, Jessie in Ohio and their two children listed as born in California.

Based on the ages, the Garbers did get stay together but didn't have any other children until 1922.
